

# **Description of Content**



#### EMS1119 Emergency Medical Technician

Cheng, David; Sheffer, Steve

EMS 1119 Emergency Medical Technician covers the U.S. Department of Transportation National Education Standards for Emergency Medical Technician. This curriculum is intended to prepare a medically competent EMT to operate in the field. This course is designed to instruct a student to the level of Emergency Medical Technician, who serves as a vital link in the chain of the health care team. It is recognized that the EMT will provide the majority of pre-hospital emergency medical care. The content of these modules includes the role and function of the EMT, ethical and legal (Ch. 401 F.S. and 64J-1 F.A.C.) aspects of EMS, lifting and moving, scene size-up, communications, documentation, overview of anatomy and physiology, patient assessment and management skills, two hours of Trauma Scorecard Methodology (Ch. 64J-1, FAC), SUIDS training consistent with Section 383, F.S., communicable diseases, ambulance operations and related hazards. In addition to class meetings and weekly on-line quizzes and assignments, students are required to demonstrate mastery of all psychomotor skills in the skills lab before being permitted to perform skills in the clinical setting. The course meets the requirements of the Florida Department of Health, Bureau of Emergency Medical Services (64J-1 FAC). Emergency Medical Technician Lab (EMS 1119L) and EMT Hospital / Field Experience (EMS 1431), are required co-requisites and satisfy additional educational requirements set by the Florida Department of Education and the Florida Department of Health, Bureau of Emergency Medical Services (64J-1 FAC).

# Skills2Work Editorial Board Subject Matter Expert Curation Process



## Why Go through the Curation Process?

Human Resources staff and other human capital talent developers need efficient and reliable methods to select quality training materials required to enhance the skills of prospective and current employees. An effectively curated collection of training materials will:

- 1. Enable workforce trainers and faculty to design and deliver high-quality courses.
- of 2. Provide a faster and cheaper approach to creating customized curricula for use by industry, workforce development boards and higher education.
- 3. Assist in keeping pace with training requirements of frequently changing workforce programs.







### Who Are the Players?

National and regional subject matter experts in a range of industry sectors will bring their years of experience and wisdom to the curation of the collection. Each industry sector will have its panel of experts who have:

- 1. Proven content expertise.
- 2. Interest in providing the industry with high quality educational and training materials.
- 3. Capacity to perform the reviews within confines of the project.
- 4. Willingness to collaborate with colleagues on the expert review panels.



### What Is the SME's Specific Role?

Within a specified time frame and overseen by Industry Sector Editors, SMEs collaboratively curate a collection of 50 items showcase items by:

- 1. Calibrating a review rubric to align with industry sector priorities.
- 2. Reviewing training materials from SkillsCommons. The expectation is each Editorial Board will review 20 courses, included in the 50 items.
- 3. Submitting completed reviews and recommendations to Industry Sector Editors.
- 4. Having the opportunity to travel to <u>OLC INNOVATE</u> 2018 in Nashville, TN, April 17 20th (April 17th 1 5:00pm pre-conference)
- 5. Communicating with Industry Sector Editor as requested.
- 6. Participating in the larger SkillsCommons community activities as appropriate.
